Welcoming Students to the 2018 National Personal Finance Challenge

High School teams from 17 states met in Lincoln to compete in the 8th annual National Personal Finance Challenge.

Nebraska State Treasurer Don Stenberg awarded \$14,000 in NEST 529 college savings accounts to the first-, second-, and third-place winners. The competition was hosted by the Nebraska Council on Economic Education.

First place went to a team from Chelsea High School in Chelsea, Michigan. Second place went to BASIS in Scottsdale, Arizona, and third place went to a team from Clarinda High School in Clarinda, Iowa.

A team from the Millard Academy of Entrepreneurship at Millard South High School represented Nebraska in the competition.

The competition was designed to test high school students knowledge of economics and personal finance and their ability to present sound advice in a hypothetical family financial situation.

Stenberg Calls on Lawmakers, Educators to Make Financial Education Mandatory in Nebraska Schools

Nebraska State Treasurer Don Stenberg has called on state lawmakers and education officials to make financial education a required course for high school graduation in Nebraska.

"Financial literacy knowledge is something every high school graduate needs and will use throughout his or her lifetime," Stenberg said in remarks prepared for delivery May 4 at a news conference, hosted by the Nebraska Bankers Association, at the Embassy Suites in La Vista.

'Over the moon'

An unclaimed property check for \$14,854 for the SCORE Camp in Imperial left the treasurer of the Chase County Schools Education Foundation "over the moon" with excitement and gratitude.

"We are thrilled to be able to have this money back where it belongs. I thank everyone involved," said Sheila Stromberg. The science-focused camp is held every other year in sites around Imperial and draws 300 campers from across the US, some in town for summer visits with grandparents.

Stromberg said she will recommend the unclaimed property money be moved into an interest-bearing CD earmarked for SCORE. She said the Treasurer's Unclaimed Property staff was very helpful throughout the process of gathering and submitting documentation to claim the money.
